This Privacy Policy explains how Miragno "we" collects, uses, and protects your data on our WordPress-hosted website www.miragno.com.

- 1. Scope & Applicability
- 1.1 Applies to all visitors/users of www.miragno.com, regardless of location.
- 1.2 Covers only data collected through our WordPress site (not offline or third-party links).

2. Data We Do NOT Collect

We explicitly do not collect:

- Financial data (credit cards, bank details).
- Biometrics (fingerprints, facial recognition).
- Government IDs (passport, SSN, Aadhaar).
- Location tracking (GPS, IP geolocation).
- Cookies/tracking pixels (unless essential for WordPress functionality).
- 3. Data We May Collect
- 3.1 Minimal, Necessary Data
 - Anonymous Content: User-submitted text (no identity linkage).
 - Optional Account Data: Pseudonym + email (if you opt to create an account).
 - Technical Metadata: Temporary IP address, browser type (for security/moderation).

3.2 WordPress-Specific Data

- Contact Form Submissions: Only if you use our WordPress forms (e.g., Contact Form 7).
- Comments: Disabled by default (if enabled, we collect only name/email).

All data is encrypted and minimized.

4. How We Use Data

- Display anonymous content (e.g., user submissions).
- Respond to inquiries (contact form messages).
- Prevent abuse (block spam via WordPress plugins like Akismet).
- Comply with laws (e.g., legal requests).

We never: Sell data, use ads/tracking, or profile users.

5. Third Party Services

We use standard website tools to operate our site securely. Some of these may collect basic technical data (like IP addresses) to function properly.

Your data is never sold. We only share information if required by law.

For security purposes, our hosting provider may keep temporary logs that are automatically deleted.

6. Data Security

- SSL encryption (HTTPS) for all data transfers.
- Firewalls (via WordPress security plugins).
- Limited access (only necessary personnel).

7. Data Retention

- Anonymous content: Retained indefinitely (no identity link).
- Account data: Deleted after 1 year of inactivity.
- Technical logs: Auto-deleted by hosting provider (30 days).

8. Your Rights

Depending on your location (GDPR/CCPA/India DPDPA), you may:

- Access, correct, or delete your data.
- Withdraw consent (for optional processing).
- Lodge complaints with a supervisory authority.

9. International Data Transfers

Data may be stored in India/EU/US with safeguards:

- GDPR: Standard Contractual Clauses (if applicable).
- CCPA/India DPDPA: No sale/sharing without consent.

10. Children's Privacy

- No data collected from children (report violations for immediate deletion).
